TERMS & CONDITIONS OF SALE

1. The Customer hereby makes application to Chief Media Pty. Ltd. (Supplier) for credit to purchase stock, subject to the terms of trade detailed hereunder.
2. If a credit account is granted to the customer the following will apply:
 - (a) All invoices are due in 30 days unless otherwise agreed by the Supplier.
 - (b) Payments are not deemed to have been made until cleared funds have been received by the Supplier.
 - (c) Legal title in all goods supplied by Chief Media shall remain with Chief Media until all goods supplied have been paid for in full.
 - (d) If the goods are resold in the ordinary course of business by the Applicant prior to paying Chief Media Pty. Ltd., then the applicant does so as agent for Chief Media Pty. Ltd. and Chief Media Pty. Ltd. will be entitled to the proceeds of the resale.
 - (e) If payment becomes overdue and without limitations it does so if there is any act or proceedings involving the Customers solvency, Chief Media Pty. Ltd. shall be entitled to recover and sell the goods.
3. The customer shall be responsible for testing and determining the suitability of the goods for the purpose for which they are intended. The liability of the Company (Chief Media Pty. Limited), to the extent that is permitted by law, shall be limited to the replacement of the material concerned, or the supply of an equivalent material, or a total refund on the cost of these goods.
4. All claims must be made within 14 days of delivery of the goods.
5. Chief Media's Price List is exclusive of GST. GST will be charged as per statutory requirements on all goods and services supplied by Chief Media Pty. Ltd.
6. Goods are non-refundable except for faulty materials.
7. No returns will be accepted without prior authority from Chief Media Pty. Ltd.
8. Chief Media will use its best endeavours to secure the delivery of goods by the estimated delivery date but it does not guarantee the time for delivery and shall not be liable for any damages or claims of any kind whatsoever in respect of delay in delivery howsoever occasioned.
